Gail Shimonek a most dedicated and knowledgeable committee member had served her maximum terms, and we were so fortunate to welcome Freda Lumgair to our committee.

#### **Programs**

Programs are up and running again after Covid. Thank you goes out to our dedicated Volunteer Drivers and the Community Coordinator who are the heart of the Transportation Program. Changes and updates to the Balance and Strength Program have seen an increase in participation and we are thankful to the gyms who have partnered with us in offering programs at reduced rates. Art Through your Eyes has been cancelled due to a lack of interest but certainly if people request it to be revived, we will look at it. The Beautiful You program in partnership with Sheer Bliss has seen an uptake on participation as well. Lymphedema Support Program has seen an increase in requests for assistance and Hope Haven continues to lend out wigs and head coverings. A Skin Screening Clinic was held in the fall with over 100 people being screened and we have a waiting list for the next one. This is a very popular and need program and we are so thankful to DR. Marnie Wiseman for volunteering her time so we can offer this program.

Special thanks to this committee who work so diligently to strive to meet the needs of our cancer clients and their families, the community, and our staff. We look forward to another active and productive year for this Committee.
